GENERAL RULES: There are certain rules which have been adopted by the Hollywood Women's Club and are made a part of this Rental Agreement. Tenant agrees to comply with the rules set forth, as evidenced by the Tenant's signature and/or initials preceding each rule below. Do not move piano, or wooden furniture or cabinets. Do not drag anything across floors. Tenant will be held responsible for damage to floors, wall, doors or other structures. No smoking, cooking, candles or any type of open flames, except sterno chafing dishes. If smoking outside, please use the containers with sand to dispose of cigarette. No open flames or torches are allowed to be placed on the lawn, walkways or porches. _____ Clubhouse chairs, tables, refrigerator, dishwasher, microwave oven and coffee pots are available for use, but Tenant is responsible for all damage brought about by misuse or neglect of such equipment by Tenant or their guests. No commercial ventures or collection of admission fees is permitted. No illegal substances, fire arms or concealed weapons on the premises. ____ No alcoholic beverages can be served to, or be in possession of, minors. ___ Tenant cannot assign this Lease or sublet the premises. _____ Tenant and guests are to park on Club property or legally on street. Do not obstruct neighbors' driveways or park on their property. _____ No animals or pets of any kind permitted inside the Clubhouse, except service or therapy animal. Proper certification for these animals must be presented at the time rent is paid. No loud music or noise is permitted in this residential neighborhood. Do not remove pictures or take anything down from the walls. ____ Do not use tape or make holes on the walls. __ Do not touch, alter or hang decorations from the chandelier. _____ All decorations brought in by Tenant must be fire resistant and must be removed by the end of each day. ___Do not alter or remove anything from Clubhouse without permission from a representative. ___ Dishes, glassware, silverware, coffee pots, etc. must be cleaned and stored properly. Garbage must be bagged, closed and placed in the outside trash bin. _____ All items brought into the Clubhouse must be removed at the end of each day, nothing can be left behind or stored for future use. Closing procedures shall include: setting air-conditioners at 84 degrees; locking the back door from the inside; turning all lights off; exiting from the front door. Please note the key you have been provided locks the bottom lock of the front door. Tenant and guests are to leave the premises promptly at end of rental period. No loitering on the property is permitted after 11:00 p.m. ____ Smoke machines and/or fog machines cannot be used in the Clubhouse.
