4 <u>CANCELLATIONS</u> : Tenant cancellations made within 30 days of the scheduled rental will incur a \$250 fee. The Club's obligation to make the Clubhouse available will be relieved if anything outside of its control prevents the facility from being available at the date and time reserved. This includes such occurrences as weather, state of emergency or other forces or events outside of the Club's control. If such occurs, the Club will reschedule at a mutually agreed upon date or will refund the Tenant's deposit and fee paid in full but will have no other liability due to such cancellation or unavailability of the Clubhouse.

Tenant agrees to comply with the rules, laws, ordinances, regulations and directions of Club representatives, governmental authorities and the Board of Fire Underwriters.
